

## **AIM Level 7 Funding**

To ensure that Access and Inclusion (AIM) supports are in place for eligible children for the 2025/26 programme call, providers are asked to please submit AIM Level 4 and Level 7 applications as early as possible. Please note, to receive payment for AIM Standard supports, a child must have an active ECCE registration in that service.

To receive payment for AIM additional hours (AIM Plus/ AIM Non-term) a child must have:

- An approved AIM Standard application in the setting they are attending for ECCE and an active ECCE registration.
- An approved AIM Plus/Non-term application in the setting they are attending for hours outside of ECCE and a confirmed NCS claim in place.

Where a child is availing of AIM Plus/Non-term in a different service to AIM Standard, please contact the child's parents/legal guardians/carers to ensure an ECCE registration has been submitted in the setting the child is attending for ECCE.

Funding queries in relation to the AIM programme should be made to the Early Years Provider Centre (EYPC) by raising a Request using the following categories:

## AIM Level 1 application process for services with new LINC







The AIM Level 1 application process has now opened on Early Years Hive for services with new graduates of the Leadership for Inclusion (LINC) programme. A 'new graduate' refers to any person graduating in October 2025.

Applicants are encouraged to submit their application as soon as possible. Applications received by 5pm on Thursday 23 October 2025 will be awarded the additional capitation from the Inclusion Co-ordinator's employment start date relevant to the 2025/2026 programme year.

Applicants are encouraged to apply early, as any applications received after this date will not be backdated.



Applications must be submitted via the Early Years Hive. Applicant guidelines can be found here. Prior to submitting the AIM Level 1 application, service providers must ensure that they have completed their ECCE programme readiness steps and activated the ECCE Funding Agreement. relating to the week ending 17<sup>th</sup> October 2025, will be processed on Monday 22<sup>nd</sup> September 2025.


#### Public consultation on the regulation of school-age childcare

is an opportunity for parents, school-age childcare practitioners, providers and other stakeholders to shape the legislation that supports the regulation of school-age childcare services. #### 2025 Learner Fund Graduates and Childminder Bursary





This year, changes to eligibility and selection criteria of the Learner Fund Bursary have been introduced to align the scheme rules with those of the Nurturing Skills Learner Fund (NSLF). The Learner Fund Bursary amount for 2025 will remain set at €1,000 however, where the demand for Learner Fund exceeds funding allocations, successful applicants will be selected based on the new eligibility and selections criteria. The rules have been amended to reflect an alignment with the NSLF scheme in relation to the eligibility criteria (and the selection criteria in case of excess demand).

#### **Tusla Registration Renewal**

All Early Years Services are required to renew registration every 3 years.



The registration date can be found on the current Tusla certificate or checked on the <u>Early Years</u>

Register or the <u>School Age Register</u>.

Please note the following key points:

- Applications must be submitted no later than 2 months before your current certification expires.
- The process requires submission of in-date Garda Vetting for the Registered Provider and the
   Person in Charge (if different). Current timelines for vetting should be considered.

Failure to reregister in time will result in your removal from the register, and it is an offence to operate an unregistered service. Additional information on re-registration can be found <a href="https://example.com/here.com/h
